### REGISTRATION and CLASS INSTRUCTIONS

- Pay close attention to cutoff dates for pre-registration. In order to not have to pay the non-registered fee you must submit the registration form on or before the cutoff date. **AN ADDITIONAL \$50 FEE IS CHARGED FOR NON-PRE-REGISTERED ATTENDEES.**
- **TO PRE-REGISTER YOU MUST MAIL IN THE REGISTRATION WITH THE CLASS FEE ENCLOSED** IN ORDER TO PRE-REGISTER, **FAXES ARE NOT ACCEPTED**
- NCSTA members do not pay for NCSTA-Sponsored classes. This is included with the membership. NCSTA membership is a company membership which means that all employees are included and do not have to pay for classes. Annual membership dues are only \$300.00. Membership is an annual membership and must be paid annually to be current. If you are not a member and wish to join NCSTA you may download a membership application from our website at [www.ncsta.net](http://www.ncsta.net) and submit the membership application with your pre-registration.
- Due to class size limitations, attendees missing the cut-off date for pre-registration will be admitted only after those pre-registered. **SEE NOTE ON HENDERSONVILLE CLASS ABOUT CLASS SIZE LIMIT**
- NCSTA accepts cash, check or money order only. Complete all blanks on registration form. Please print clearly.
- A separate registration form should be completed for each person attending. Class fees are per person attending.
- The fee that you paid to NCOWCICB was for certification and does not include membership to NCSTA or Education fees.
- Employees of Environmental Health departments seeking hours for RS may take the classes at no charge provided that a pre-registration is received on or before the cutoff date for pre-registration. Those registering at the door will be charged a \$50.00 fee.
